#### **Business Arising**

Traps: Jorgen Jensen organised an order of traps through Western Trapping Supplies. Cost was \$11,118.00. Additional chain will need to be purchased from DTS.

LPMT Training (AWI funding): Is there a possibility to use this funding to support Jon Hehir to provide the landholder training? EO to check with AWI for this.

LFH Shoot planned for October 23 – is this still going ahead? Damien Swain (DPIRD) gave an indication that firearms permissions will be cleared and OK to go ahead.

Chair asked if there is still a need for LFH cull in the northern area? Clyde Hall advised that aerial operators do still see plenty of donkeys, some camels. Chair to ring Krystie Bremer CRBA re Carnarvon's LFH operations.

#### 5. UPDATE FROM THE EXECUTIVE OFFICER

- Operational Plan for 2022/2023 was submitted; however, further adjustments to budget figures meant that this is still pending. Operational Plan now meets the format requirements of DPIRD and this will make future plans easier to complete.
- Operational Plan for 2023/2024 will be submitted as soon as DPIRD give approval for previous year's plan and once 2023/2024 budget is reviewed.
- Reporting for Royalties for Regions / Wild Dog Action Plan funds is due now, along with next invoice.
- Meat order has been lodged with Pets Meat Suppliers; need confirmed amounts and dates for delivery to each bait rack station.
- NEED TO GET 3 TO 4 QUOTES FROM SUPPLIERS FOR BAIT MEAT
- Grants available through DPIRD: Capacity Building and Research, open now, closing October 1, 2023, up to \$3K.
- Grants available through DPIRD: Competitive R&D grants (WA WDAP 2021 – 25), closing March 3, 2023, minimum \$20K, maximum \$100K.

#### DBCA

- o MoU
- Operations on DBCA managed land
- Impact of this on future R4R funds for LPMTs
- Much correspondence with DBCA regarding wild dog control on their properties.
- Need to approach ministers and/or DBCA from MRBA, CRBA and GNRBA. Ask a direct question – do you want dogs controlled on this land? Why? What is the reason? Go to Nigel Sercombe first. BAM Act requires land owners to managed declared pests. Are DBCA exempt? Then go to Minister with the argument.
- Motion: MRBA's EO write to DBCA demanding clarification on contractual arrangement for management of wild dogs on DBCA land.

**PIGS: Noticed on Mt Clere**

Similar to donkeys out of Boolardy and Manfred, moving into Kalli and then Belele country. Might be worth talking to Murchison Shire regarding CSIRO / SKA obligations given that they are a landholder and are still obliged to control declared pests.

## LPMT Rates:

Recommended: \$600/day (plus GST) for a 10 hour day, however, the budget actuals need to be updated and then forecast budget confirmed, prior to revising LPMT rates.

Also need to revise and update LPMT Contracts.

## **Committee Members:**

### **S7 Poison Retailer:**

Ashley Dowden: seeking someone else to take on the S7 Retailer business.

## Mt Magnet Compound:

Peter Savage: Access to compound at Mt Magnet? Situation arose where Peter planned a collection from the compound, but on arriving found that the only person with the key to access this was out of town. Needs to be clarified as to who provides this access, and ensure that if that person is absent, that there is a back-up.

#### **Minister Jarvis:**

Jorgen: Need to keep contacting Minister / Policy Advisor / Chief of Staff for a meeting with Minister Jackie Jarvis. EO to email weekly.

### WDAP/R4R/DBCA Land:

EO: to talk to Tim Thompson FIRST regarding WDAP / R4R funding. Ask him about the need to manage / control BUFFER ZONES around DBCA managed lands, and ongoing funds to do this work.
